*Central to the awarding of the tuition subsidies, as with all parish fiscal matters, we strive to exercise good stewardship with all funds entrusted to us by our parishioners.*

*So that the parish has the monies available to help as many parish families as possible, especially those with the greatest need, you are asked not to apply for a parish-awarded tuition subsidy:*

- (1) if your family is financially capable of paying your tuition.*
- (2) if you receive a subsidy through the Catholic Education Foundation.*
