**Follow these easy steps:**

- Make your gift to CCF (there are exceptions, please see matching gift restrictions)
- Contact your employer for a matching gift form or link to their matching gift website, and complete the necessary information.
- Send matching gift forms or your employer's online matching gift link to the Donor Relations Office at the Catholic Community Foundation (CCF), and we will verify that your gift was made and process matching gift forms with your employer.
